Associate Professor Brett Courtenay, OAM

A/Prof Courtenay is an Orthopedic Surgeon whose practice is on St Vincent's Campus. He has been a VMO at St Vincent's Hospital since 1984. His early residency was at St Vincent's Hospital, commencing in 1975 and he finished the orthopedic training scheme at St Vincent's Hospital in 1982. He is involved with many committees at St Vincent's Hospital and NSW Health. In 2021, MS Research Australia won the Prime Awards NGO of the Year thanks to the success of The May 50k and the virtual challenge also won the FIA Award for Impact through Events.

In 2015, he was awarded the Harvard Club of Australia NFP Fellowship and was shortlisted for the CEO Magazine NFP CEO of the Year in 2016. During his tenure as CEO, MS Research Australia was named Charity of the Year in 2015 by the Australian Business Awards and the Telstra Charity of the Year in 2017. It was the first charity to win a Telstra Business Awards when it was also named the Telstra NSW Business of the Year in 2017.
